In circumstances where the exemption is based upon ongoing medical conditions, the supporting the supporting medical documentation must be signed by the licensed healthcare provider who is responsible for providing ongoing medical care to the individual who is applying for the exemption. (Note: Providers cannot provide this supporting medical documentation about themselves. The supporting medical documentation must come from the requesting individual's primary care physician or PCP's practice, or other clinician who is actively involved in providing medical care to the individual who is requesting the Medical Exemption.) For providers who are pregnant, documentation showing the requestor's due date is required. • Religious Exemptions from the Ascension COVID-19 vaccine requirement will also use this link. <p style="text-align: center;"><i>If exemption is not granted suspension will be effective 11/12/21</i></p>
